Job requires flexible, non-traditional work schedule including evenings and weekends. Will be "on call" via pager/cell phone. Serves as a field officer for field supervision of offenders who are granted Home Detention, Day Reporting or Problem Solving Court status. Work will be performed primarily in the field (i.e., at the homes, schools, and workplaces of offenders). A county fleet vehicle is generally available, but applicants must be able to use personal vehicle to make field visits if necessary; mileage reimbursed at Monroe County rate.

Must have valid driver's license, ability to use personal vehicle for work purposes, and appropriate vehicle insurance. Experience and/or training in correctional/law enforcement field preferred. Ability to use and troubleshoot electronic monitoring equipment and software for Home Detention. Ability to work as member of a team. Ability to work night and weekend hours. Must have excellent written and verbal communication skills. Must have knowledge of, and experience using, the Microsoft Office Suite (Word, Excel, Outlook). Working knowledge of (or willingness to learn) other computer programs. Ability to effectively communicate with the public. Must submit to criminal records check and drug test.
