Why do you wish to hold this position? What do you hope to accomplish as a POPAI Board Member?

I wish to move the probation profession forward in the state of Indiana by:

 working with partners such as IJC and DOC to train all Indiana probation officers in basic skills necessary to implement evidence-based correctional practices (EBP);

- working with the Indiana General Assembly to obtain funding for probation services in the state that allows probation caseloads and workloads to be reduced across the state to levels recommended by the American Probation and Parole Association and the Judicial Conference of Indiana;
- working with POPAI membership to share "best practices," policies/procedures, training and other resources to avoid duplication of efforts and support other probation departments to become evidencebased organizations;
- working with the POPAI Chief Executive Committee to continue to support and grow new probation leaders in the state.

Discuss the issues you view as most important to Probation in Indiana.

- 1) Probation officer caseloads and workloads are too high across the state. The issue of workload must be addressed by the Indiana Judicial Center in order to make arguments to the Indiana General Assembly regarding the recommended caseload/workload levels, similar to the caseload limits adopted for DCS case workers.
- 2) Probation officer positions are being cut across the state in part due to the "unfunded mandate" issue and declining/disappearing user fees. We need to sustain the existing probation officer positions while also working with our DOC partners to expand probation services across the state to appropriately implement the revised Indiana criminal code.
- 3) Education of probation officers in EBP; need easier access to initial and ongoing training readily available for newly hired POs.

Attendance at POPAI Board meetings is vitally important to the organization. Board members are expected to attend the scheduled meetings in person with minimal absences. TheBoard meets the second Wednesday of each month in Indianapolis, 10:30 AM – 1:30 PM. Possible exceptions:

- February Board meeting is held at the POPAI Management Institute.
- May the Board may meet for half a day retreat the morning before PO annual meeting.
- September on Friday of POPAI Fall training in French Lick.
- Some POPAI Board meetings may be held via conference call due to weather or light agenda.

Board members must work on at least one POPAI Committee. Standing committees: Election; Awards and Recognition; Technology/Website; Education; Legislation; Membership.
