POPAI Corporate Sponsor Policy

POPAI has established the following policies to create a professional and ethical partnership with our corporate sponsors*.

1. Sponsor Table Usage & Registration

- Paid Sponsors must use only their assigned table(s). Moving, swapping, sharing, or adding tables is not permitted without prior approval from a POPAI Staff or Board Member.
- 2. Table sharing between companies is strictly prohibited.
- 3. Alcohol in any physical form may not be distributed from any sponsor table during the established vending day periods.

2. Photography and Public Representation

- 1. Publication or posting of Photos or videos depicting probation officers in a manner that could be considered unprofessional or inappropriate are strictly prohibited.
- POPAI reserves the right to request removal of any social media or promotional content associating POPAI or its members in conflict with POPAI's philosophy and ethical standards.

3. Sponsor Registration Integrity

- 1. Sponsor tables are available on a first-paid, first-reservation-opportunity basis and are limited to the space provided by the venue.
- 2. The number of paid sponsors is limited by venue capacity in both Spring (Management Institute) and Fall (Fall Conference) to ensure table space is reserved for them. A registration process is required before each event.
- 3. A company representative may not register as an attendee to bypass sponsorship space limitations or costs.
- 4. Attendee lists provided with the Gold, Silver, and Bronze packages may not be shared/sold/traded with other companies or entities.

4. After-Hours Activities

- 1. Any sponsor planning an event, gathering, or promotional activity in connection with a POPAI event must notify POPAI Board members or staff at least 30 days in advance.
- 2. Events must not conflict with scheduled POPAI programming.

5. Sponsor Reputation and Service Quality

- POPAI reserves the right to decline or revoke sponsorship if a company is known to provide substandard or poor-quality products or services, as evidenced by documented concerns from POPAI members.
- 2. Companies that fail to meet professional and ethical standards may be barred from future sponsorship opportunities.

Enforcement

POPAI Board or its designee reserves the right to take appropriate action, including removal from an event, revoking sponsorship, and/or exclusion from future sponsorship opportunities.

Article V Membership A. Qualification Section 5. Corporate Membership

Corporate membership shall be awarded/limited to corporations or foundations who wish to contribute to POPAI and whose products, services, philosophy, and/or conduct are not in conflict with the Association.
